At the outset, the Secretary welcomed the Mayor, members and officers present in the Committee.

**AGENDA ITEM NO. 1**

**Confirmation of minutes of 202<sup>nd</sup> meeting of the Finance and Contract Committee held on 10.11.2010 at 11.00 a.m. in the Committee Room of MC, Chandigarh.**

The Secretary put up agenda item No.1 before the Committee for confirmation.

The S.E.(B&R) pointed out that at page 14 of the minutes of 202<sup>nd</sup> meeting, in the Resolution of Table Agenda Item No.6, an amount of Rs. 3.02 lac be added in the last line of the resolution.

***The Committee confirmed the minutes of 202<sup>nd</sup> meeting of F&CC held on 10.11.2010 with the following amendments :-***

*The 2<sup>nd</sup> para of the resolution of Table Agenda Item No.6 at page 14 be read as under :-*

***“The Committee also decided that Boom Barrier (Parking Access System) be also provided in the Parking in front of M/s Sahib Singh in Sec-17, Chandigarh and also approved the proportionate expenditure i.e. Rs. 3.02 lac for the said parking.”***

The Mayor asked as to what action has been taken on the decision of the F&CC in the matter of mobile towers and fresh agreement with increase rent.

The S.E.(B&R) replied that there is no specific address of the company where the notice can be served, neither anybody has come forward to execute the agreement

The Mayor asked whether the decisions of the F&CC regarding distribution of work in Enforcement Wing and division of work among Executive Engineers of Road Divisions have been implemented. However, she desired that the decisions of the F&CC should be implemented in letter & spirit. She further said that earlier it was decided to privatize the complaint centre for which an agenda was to be placed before the Committee, but so far no agenda has been brought. She stressed that agenda in this regard be placed in the next meeting of the F&CC.

Sh. Ram Lal pointed out that the development work in Village Hallomajra has not been started even after lapse of 10 months after allotment of work.

The S.E.(B&R) said that some projects could not be started due to non-availability of material as the High Court has imposed ban on quarries in the adjoining states.

**The Mayor and all members said that the contractors who have not started work on the projects for last two years should be blacklisted.**
