Subject: Development of Green Belt at Village Kajheri Sector 52, Chandigarh under Landscaping.

Rs.17.35 lac

Sh.Kuldeep Singh, the area councillor (Ward No.12) instructed for development of Green Belt at Village Kajheri Sector 52, Chandigarh. Accordingly the Rough Cost Estimate has been framed amounting to Rs.17.35 lacs under Landscaping Head. The estimate amounting to Rs.17.35 lacs has been checked and approved by C.M.C. for placing before Environment and City Beautification Committee. As the amount of the estimate is beyond the competency of above said committee and the same was recommended to put up before F&CC (Copy of minutes dated 3.8.2011 attached). The following scope of work has been taken in the estimate.

AGENDA ITEM NO. 3

Subject: Providing and fixing 60mm thick interlocking paver blocks in front of houses in Sector 30-A, Chandigarh.

Rs.34.32 lac

The area councilor, Sh. Davinder Singh Babla has desired to provide paver blocks on the existing footpath in front of houses of Sector 30-A to facilitate the general public. The residents of the area has also demanded the same. This area was inspected by the Executive Engineer, Roads Division No.2 alongwith Sub Divisional Engineer, Roads Division No.7, M.C and It has been noticed that site is feasible for providing paver blocks.

Accordingly a rough cost estimate amounting to Rs.34.32 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works.

1. Dismantling of existing kerbs and stacking the serviceable kerbs.
2. Dismantling of existing channels and stacking the serviceable channels.
3. Earth work in excavation
4. Carriage of earth
5. Preparation of sub grade
6. C.C.1:8:16 with 40mm gauge stone aggregate
7. P/F PCC kerbs of size 2'-0x9" having 4" thickness
8. P/F PCC channels of size 2'x1' having 3" thickness
9. P/F 60mm thick interlocking paver blocks.

The expenditure on this work shall be charged under Head "4217 (P) Roads & Bridges". The budget allocation cost of already approved estimate and expenditure incurred under this head is as under:

Subject: Fixation of reserve price of Exhibition Ground Sector 34, Chandigarh.

As per past practice, on the eve of Diwali festival this year also, the Exhibition Ground Sector-34, Chandigarh is to be auctioned for 10 days to put stalls etc. from 17th October 2011 to 26th October 2011. In addition to the said period, the successful bidder are allowed five days period prior to diwali mela and 2 days after Diwali Mela i.e. from 12.10.11 to 16.10.11 and from 27.10.10 to 28.10.11 for installation and dismantling of material @ Rs. 500/- per day with certain conditions (conditions attached herewith).

Earlier in 208th meeting of F&CC an agenda was moved regarding relocation of licensees of fire crackers from Nehru Park and committee passed the following resolution:

“The Committee considered & resolved that cracker stalls shall not be allowed in Sector 22 during Diwali Festival. The Committee further resolved that Circus Ground, Sector 17, be allowed to be used for installation of cracker stalls during Diwali Festival at the prevailing ground rent or alternative suitable site be identified.”

Earlier in the 209th meeting of F&CC an agenda for the auction of two grounds and fixation of reserve price was put up and the committee passed the following resolution that ;

“ The Committee observed that fire cracker sellers have also been allowed to sell crackers at Circus Ground during Diwali festival as per decision of F&CC taken in its meeting held on 20.6.2011, vide Agenda Item No.6. Therefore, the matter be examined again keeping in view the above decision and agenda be prepared accordingly.”

Keeping in view of above resolution we may auction the Exhibition Ground Sector 34, Chandigarh for holding Diwali mela for 10 days. The reserve price and price fetched by the auction of above ground and park for the last three years are as under: -

Subject: Rough Cost Estimate of Mini Bus Stand, Village Maloya, Chandigarh.

Rs.32.43 lac

Sh.Harphool Chander Kalyan, Area Councillor of Ward No.7, Municipal Corporation, Chandigarh requested that the residents of Maloya and adjoining areas demanded that Mini Bus Stand may be provided at the entrance of Village Maloya to facilitate the commuters. The request was forwarded to the Chief Architect, Department of Urban Planning, Chandigarh Administration, Chandigarh and the site was visited by Chief Architect, Department of Urban Planning, Chandigarh Administration, Chandigarh, Chief Engineer, Municipal Corporation, Superintending Engineer (B&R), Municipal Corporation, Chandigarh and Area Councillor and it was decided to provide stainless steel Bus queue Shelter and construction of Mini Bus Stand.

Accordingly the Chief Architect, Department of Urban Planning, Chandigarh Administration, Chandigarh vide their office Memo No. 8514 dated 05.07.2011 supplied the conceptual approval to the proposed Bus Queue Shelter at village Maloya.

Thereafter the rough cost estimate has been framed amounting to Rs.32.43 lacs for seeking Administrative approval from the competent authority. The following scope of the work has been taken in the estimate is as under:

1. Providing and laying GSB spreading and two layers of the stone aggregate of 63-45 & 53-22.4mm
2. Providing and laying in position cement concrete 1:8:16
3. Brick masonry, cement plaster, angle iron nosing and railing upto 3'-0" height
4. Providing and laying surface dressing
5. Providing and laying 40mm thick bituminous concrete and tack coat
6. Providing and fixing PCC Kerbs/Channels
7. Const. of stainless steel bus queue shelter.

Components of work:

1. Construction of parking upto surface dressing.
2. Providing and laying 40 mm thick bituminous macadam.
3. Providing and fixing 60 mm thick paver blocks and civil works.
4. Construction of stainless steel Bus Queue Shelter.

The expenditure on this work shall be charged under Head “4217 (P) R&B.” The budget estimates, budget allocation, amount of already approved estimates and expenditure under this head for Roads Division No.3 is as under:-

Subject: Purchase of shrub master for use in Horticulture Division, M.C., Chandigarh.

New area has been transferred from the Chandigarh Administration to M.C., Chandigarh vide notification issued by the local Government of Chandigarh bearing No. 17/6/10-FII(8)-2010/0814 dated 30th September 2010. To cope up with the work load an estimate amount Rs. 8.14 Lacs has been prepaid for the purchase of 10 nos. more shrub master as the area has been increased and additional machinery is required urgently for the maintenance of transferred areas. Therefore, the estimate for the purchased for shrubmasters has been prepared, checked and approved by C.M.C for placing before F&CC. The following scope of work has been taken in the estimate.

Shrubmaster (10 nos.)	=	Rs. 7,90,000/-

AGENDA ITEM NO. 7

Subject: Regarding annual maintenance contract for Hydraulic Platform cum Turn Table Ladders (02 nos.) stationed at Fire Station, Manimajra and Fire Station, Sector 17, Chandigarh.

The office purchased 02 nos Imported Hydraulic Platform cum Turn Table ladders (HPTTLs) through M/s Brijbasi Fire Safety Systems Pvt. Ltd, New Delhi from Bronto Skylift OY AB, Finland in July 2005 and 2007 respectively. The vehicles were under warranty for the period of two years from the date of its purchase. The office engaged M/s Brijbasi Fire Safety Systems Pvt. Ltd, New Delhi for the Annual Maintenance Contract for the 1st HPTTL vehicle no. CH01G1-4200 placed at Fire Station, Sector 17, Chandigarh on payment of Rs 3.00 lac per year for three years which expired in March, 2011. The warranty period of 2nd HPTTL vehicle no. CH01G1-1880 has also been expired.

The office requested M/s Brijbasi Fire Safety Systems Pvt. Ltd, New Delhi (being sole agent) to send proposal for the AMC of both the vehicles and the firm demanded Rs. 6.50 lac vide their request dated 24.02.2011 (Annexure A-1). The Director of the firm was called for negotiations regarding the amount to be paid for AMC of both the HPTTL vehicles per year and after detailed deliberation, he accepted the amount of Rs. 5.00 lac per vehicle per year + service tax (Annexure A-2). The cost of the below mentioned spare parts and custom duty is included in the above offered price: -

The Director, M/s Brijbasi Fire Safety Systems Pvt. Ltd, New Delhi also submitted the copy of the Annual Maintenance Contract between the M/s Brijbasi and Indian Oil Corporation of the HPTTL vehicle amounting to Rs 5.85 lac + service tax. M/s Brijbasi Fire Safety Systems Pvt Ltd, New Delhi also provided satisfactory service during the warranty and AMC period.

Keeping in view the above said position it is realized the office may engaged M/s Brijbasi Fire Safety Systems Pvt. Ltd, New Delhi for the AMC of both the Hydraulic Platform cum Turn Table Ladder vehicles on payment of Rs 5.00 lac per vehicle per year + service tax. The AMC may be for three years without any increase in the payment.
