### **AGENDA ITEM NO. 3**

**Subject:- Rough cost estimate for “Strengthening of SWD system at phirni road in village palsora, U.T., Chandigarh.”**

The existing SWD System for the village was provided earlier by Chandigarh Administration and transferred to Municipal Corporation, Chandigarh during March, 2007 along with 05 No. of other villages. The rain water disposal system was provided by laying pipe line with the purpose to cover the surface drain and the road gullies were provided in series which results into persistent blockage of the line. As such the existing storm water drainage system is not adequate. Further the area has also been visited by the Hon’ble Mayor, Municipal Corporation, Chandigarh along with Senior Deputy Mayor, Deputy Mayor & Chairman, Water Supply & Disposal Committee and desired to provide the proper drainage system for disposal of rain water. Accordingly the detailed survey has been carried out by the concerned SDE for the feasibility and preparation of the rough cost estimate. The estimate so prepared contains the proposal to lay approximately 544 mtr. long RCC NP-2 pipes of sizes 14” i/d, 16” i/d and 18” i/d. along with provision for construction of 14 No. road gully chambers and 14 No. manhole chambers and other contingent items along the phirni road of the village. The detail of estimated amount is as under:-

Seven agencies have participated, out of which, following six agencies were found to be technically pre qualified and informed accordingly by the E.E.R.-1 to the agencies and the financial bids were opened on 14.8.2012. The rates quoted by M/s Sam (India) Built Well Pvt. Ltd., # 435 Jagriti Enclave Vikas Marg Extension Delhi, as downloaded from e-tender depicts quoted Rs.00.00 rates of all the items. E.E.R-1 has intimated that M/s Sam (India) Built Well Pvt. Ltd., # 435 Jagriti Enclave Vikas Marg Extension Delhi has intimated vide their letter dt. 18.8.2012 (copy of letter enclosed) that his rates quoted were not uploaded due to some unknown reasons and requested for release of earnest money, which has not been released so far by the E.E.R-1. As such, the tender was considered as invalid due to claim of agency that on e-tendering rates quoted file not uploaded due to some unknown reasons.

As per General Conditions of Contract for Central PWD Works, 2010, Rule-10, Page – 6, applicable for item Rate Tender only as produced below:

“ In the case of Item Rate Tenders, only rates quoted shall be considered. Any tender containing percentage below/above the rates quoted is liable to be rejected. Rates quoted by the contractor in item rate tender in figures and words shall be accurately filled in so that there is no discrepancy in the rates written in figure and works. However, if a discrepancy is found, the rates which correspond with the amount work out by the contractor shall unless otherwise proved be taken as correct. If the amount of an item is not worked out by the contractor or it does not correspond with the rates written either in figures or in words, then the rates quoted by the contractor in words shall be taken as correct. Where the rates quoted by the contractor in figures and in works tally, but the amount is not worked out correctly, the rates quoted by the contractor will unless otherwise proved be taken as correct and not the amount. **In even no rate has been quoted by any item (s), leaving space both in figures (s), word(s) and amount blank, it will be presumed that the contractor has included the cost of this/these item (s) in other items and rate for such item (s) will be considered as zero and work will be required to executed accordingly.**”

As a general practices if the agency does not quote rate for any item, in an item rate tender, it is treated as zero rate and that item is to be executed free of cost by the agency. But in the instant case the rate for entire work i.e. for all 71 nos. items are depicted as zero as claimed by the agency that on e-tendering rates quoted file not uploaded due to some unknown reasons, so the cost of entire tender is Rs. Zero

which seems unjustified and the agency can not execute the entire work free of cost. Moreover, even after treating the tender of M/s Sam (India ) Built Well (P) Ltd. as invalid, there are five other agencies which have quoted rates and the tender can be awarded based on the financial statement of the other five agencies.

In view of above, following issues are placed before the Finance & Contract Committee for its consideration and decision.

1. To treat the tender of M/s Sam (India) Built Well Pvt. Ltd., # 435 Jagriti Enclave Vikas Marg Extension Delhi India, as Invalid and to decide the tender based on the financial bid of remaining agencies.
2. For deciding the action to be taken against the agency for not uploading the rates.
