Subject: Revised RCE for Providing rigid pavement along the road leading from Purv Marg to Railway Station road in industrial Area, Phase-1, Chandigarh. (Below Railway Bridge)

(Amount: Rs.93.72 Lac)

The estimate for the above said work was administratively approved vide CEMC O/o No. 185 dated 8.6.2011 amounting to Rs.63.38 Lac. The work is allotted to the contractual agency vide this office letter No. 1343 dated 11.02.2011 amounting to Rs.74,76,805/-. The total amount of the estimate is enhanced from ` 63.38 lacs to Rs.74.77 lacs at the time of allotment due to increase in market rates. Moreover, the cost of work increased from Rs.74.77 lacs to Rs.93.72 lacs due to execution of some extra items as per site requirement as mentioned below:

1. 6mm thick sand cushion.
2. Shuttering of edges of slab
3. P/f PVC end cap
4. Extra for doing vacuum dewatering process.
5. Steel reinforcement.

It is pertinent to mention that as per record, this road was lastly carpeted in the year of 08/2006 and as per policy of Municipal Corporation, the recarpeting is to be done after 5 years, which was due for recarpeting during this year. This road was inspected by the Executive Engineer, Roads Division No.2 alongwith Sub Divisional Engineer, Roads Division No.7, M.C and it has been observed that lot of cracks and pot holes have been developed on the road surface, causing inconvenience to the public. Accordingly a rough cost estimate amounting to Rs.78.68 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works.

Subject: Re-carpeting of Road passing through main market in Modern Housing Complex, Manimajra.

(Amount: Rs.42.84 Lac)

The road passing through main market in Modern Housing Complex, Manimajra was earlier re-carpeted in the year 9/2007. The widening of this road is in progress which is likely to be completed by 30th September 2011. To avoid ugly look of joint and for smooth flow of vehicles, it is necessary to recarpet the road in whole width i.e. existing road alongwith widened portion. This road was inspected by the Executive Engineer, Roads Division No.2 alongwith Sub Divisional Engineer, Roads Division No.5, M.C and It has been noticed that the crust of road starts damaging at the junction of existing road and widened portion. It has also been observed that lot of cracks and pot holes have been developed on the road surface, causing inconvenience to the public.

Accordingly a rough cost estimate amounting to Rs.42.84 lacs has been prepared for arranging administrative approval and allotment of funds. The estimate includes the following scope of works.

1. Providing and applying tack coat.
2. Providing and laying 40mm thick Bituminous Concrete.

The expenditure on this work shall be charged under Head “4217 (P) Sub Office Manimajra”. The budget allocation cost of already approved estimate and expenditure incurred under this head is as under:

Subject: Estimate for B/I one no. 12"x8" (304.80x203.20 mm) i/d deep bore tubewell (with reverse rig method and any method of latest technology) and Construction of R.C.C. U.G.R. of 1,00,000 Gallons Capacity along with boosting arrangement in Sector 39-B, (Near HRY, Govt. Houses), Chandigarh.

(Amount: Rs.65.48 Lac)

The estimate has been prepared for the work of B/I one no. 12" x8" (304.80 x 203.20mm) i/d deep bore t/well and construction of U.G.R. of 1,00,000 Gallons Capacity along with boosting arrangement in Sector -39 B (Near HRY, Govt. Houses), Chandigarh for feeding to distribution water supply system. The necessity of this estimate has arisen due to low pressure complaints of water supply in sector 39, Chandigarh. The area councillor has also requested to augment the area to tackle the problem of low pressure of drinking water supply.

Due to the transfer of work regarding 5th and 6th phase of water supply system from Kajauly (PB) to sec.39,Chd., there is a shortage of drinking water supply. So it has been proposed to provide Deep bore tubewell with suitable size screen and Construction of R.C.C. U.G.R. of 1,00,000 Gallons Capacity along with boosting arrangement to cater the problem of shortage of drinking water in Sector -39 B (Near HRY, Govt. Houses), Chandigarh .

It has been proposed for B/I of 01 No. tubewell and construction of R.C.C. U.G.R. of capacity 1,00,000 gallons with provision for the pumping machinery along with required number of C.I./M.S. specials. Provision of D.I. & M.S. pipe taken in the estimate for connection to the U.G.R. with distribution network. Provision for electricity connection charges and construction of pump chamber alongwith toilet block has also been made in the estimate.

As such, an estimate amounting to **Rs. 65.48 Lacs** duly allowed by the competent authority is placed before the **General House of the Municipal Corporation** for its consideration and approval. The expenditure shall be chargeable to the Head:- 4215 (Plan)- Providing new tubewells and pipe lines

Subject: Rough Cost Estimate for providing and laying 50 mm thick bituminous macadam and 40 mm thick bituminous concrete on V-3 road dividing Sector 52/61, Chandigarh.

(Amount: Rs.91.62 Lac)

V-3 roads have been recently transferred to Municipal Corporation, Chandigarh by Engineering Department, Chandigarh Administration, Chandigarh. The condition of V-3 roads between 52 and 61, which has been transferred to this Division vide worthy Chief Engineer, M.C., Chandigarh office order No.57 dated 05.05.2011 is very poor and uneven. Lot of pot holes and big cracks are existing on this road and the same can not be restored without laying of bituminous macadam. The day to day maintenance is not able to make road satisfactory. This road was last carpetted by Chandigarh Administration, Road Wing during October, 2005 and as such road is due for recarpetting as policy of Municipal Corporation.

Accordingly, the rough cost estimate amounting to **Rs.91.62** lacs with the following scope of the work has been framed:

1. Dismantling of existing kerbs.
2. Dismantling of existing channels.
3. Fixing of new/old PCC kerbs.
4. Fixing of new/old PCC channels.
5. Providing and applying tack coat.
6. Providing and laying 50 mm thick Bituminous macadam.
7. Providing and laying 40 mm thick Bituminous concrete.

(Amount: Rs.40.56 Lac)

The condition of V-4 road in Sector 43, Chandigarh is in very poor and uneven. Due to main bus stand located in Sector 43, most of local buses, autos passes through this V-4 road. Lot of pot holes and big cracks are existing on this road and the same can not be restored without laying the patchwork with bituminous macadam. The day to day maintenance is not able to make road satisfactory. This road was last carpeted during March, 2006 and as such road is due for recarpetting as policy of Municipal Corporation. The Area Councillor and resident Welfare Association are pressing hard for early recarpetting of this V-4 road.

Accordingly, the rough cost estimate amounting to **Rs.40.56** lacs with the following scope of the work has been framed:

1. Providing and applying tack coat.
2. Providing and laying bituminous macadam. (for patch work).
3. Providing and laying 40 mm thick B.C.

5. Providing and laying damp - proof course. 40 mm thick with cement concrete 1:2:4.
6. Pointing on brick work.
7. 12 mm thick cement plaster of mix 1.4.
8. Finishing walls with acrylic smooth exterior paint.

Subject: Estimate for the work of “Providing and fixing of Ms wire mesh Jali with Ms angle iron around raw water storage tanks No.3,4,5,6 & 7 at water works Sector 39, Chandigarh.

There are 7 no. raw water storage and sedimentations tanks each of 6 million gallon capacity at water works, Sector-39, Chandigarh which are used to store canal water being received from water works, Kajauli for use in case of shut down or any other failure to receive canal water from Kajauli. These tanks are about 12 feet deep and are uncovered. As such for security and protection against mishap, MS railing is required to be provided. However earlier MS railing for only tank No. 1 was provided. Thus it is proposed to provide MS angle iron railing duly fixed with MS wire mesh jali around remaining 5 No. tanks i.e. tank no. 3,4,5,6 & 7. The tank no. 2 is closed as it is cracked/broken and requires major repairs and strengthening, therefore the railing for the same has not been proposed. The estimate for its repair and provision of railing for storage tank No. 2 shall however be processed separately. The proposed railing shall consist the use of MS wire mesh jali 10 gauge of size 25mmx25mm to be fixed in frames of angle iron 40mm x 40mmx6mm and Tee iron of designation ISNT 40 having clear height of 4’-3” from top of wall to top of railing. The total area of railing and gates for 5 no. raw water storage tanks at water works is approximately 29400 Sft. Thus the estimate duly checked for **Rs. 44.61 Lacs** has been allowed by the competent authority to be placed before the General House of Corporation for consideration and approval.

Accordingly the agenda is hereby placed before the General House of Municipal Corporation. The expenditure will be charged to head: 4215 – Water Supply and Sanitation (Plan) – Renovation of civil works and more funds will be demanded in RBE. However the detail of Budget allocation is as under:

Subject: Providing 36" SWD line for low laying area at modern housing complex (Duplex) from booth market to Kalka road near Kalagram at Manimajra U.T., Chandigarh.

REPORT:-

The necessity of the estimate has arisen as area of Duplex houses near Booth market gets flooded during heavy rains and water stagnates for a long time. There is natural slope of the Modern Housing Complex particularly duplex area towards the booth market which is the lowest point and the water of entire Duplex houses stagnates near the booth market. It takes ½ to ¾ hours for disposal of water after heavy rain. The local area residents and owners of booth have requested Advisor to the Administrator, UT Administration, Chandigarh to look into the matter. The disposal of the storm water of this area is towards the open nallah near Sheetla Mata Mandir which itself overflows during heavy rains. It is not able to take full discharge of the water of the Modern Housing Complex Duplex area. This is a overdue problem for the last many years and a number of requests have been made by the residents of the area to Chandigarh Housing Board & Municipal Corporation. The area was visited by Chief Engineer M.C and Chief Engineer CHB and it was decided to lay a 24" i/d RCC pipe and 40" o/d MS storm water line from Booth market, passing near Bitta petrol Pump and to be connected after crossing the National Highway. Accordingly the estimate amounting to `51.45 lacs has been prepared to cover the cost of providing 36" i/d RCC pipe and 40" o/d MS pipe for disposal of storm water into the existing 48" i/d RCC pipe adjoining Kala Gram.

As such the estimate costing `51.45 lacs duly allowed by competent authority is hereby placed before the house of the Municipal Corporation for consideration and approval. The funds amounting to Rs. 2100 Lacs have been approved by Municipal Corporation for the year 2011-12 under Plan Head 4217-Storm Water Drainage.

Subject: Boring and installing of one no. new 12” x 8” (304.80 x 203.20 mm) i/d deep bore tubewells along with pumping machinery and other allied works (with percussion-cum-rotary drilling rig/any other method of latest technology) and construction of 1 lacs gallon capacity UGR along with boosting arrangements and other allied works at Dera Sahib area in Manimajra, U.T., Chandigarh.

REPORT:

The area of Dera Sahib is height to as compared to other areas of Manimajra. The area is also at the end of the distribution network of the Water Works-I at Mansa Devi Road & due to which the water reaches in that area very late. The existing lines supplying water to the area of 4” i/d are small. Keeping in view the increased population in the area as the lines were laid more than 25 years back. The occupancy rates per square yard in this area is very high. In summer the area faces extreme problem of water supply as the requisite pressure does not built up due to small size of line and increased consumption. Accordingly SDE incharge of the area has surveyed thoroughly and the necessary field data submitted to this office and proposed to provide one no. new tubewell & booster of 1 lac capacity to feed directly this area.

The strata of the area is very hard and it is not feasible to go for reverse rotary method. The boring is feasible with percussion boring. This type of boring is also being done by Engineering department U.T. and HUDA in this area.

Hence the detailed estimate amounting to Rs. 60.26 duly checked and allowed by competent authority, is hereby placed before the House of Corporation for consideration & approval.

The funds amounting to Rs. 1000.00 Lacs have been allotted to Public Health Circle under the head Providing new T/Wells and Pipelines. The expenditure will be met out of above allotted funds.

Subject: Rough Cost Estimate for Providing and laying 40mm thick Bituminous Concrete on V-4 road in Sector 21, Chandigarh.

(Amount: Rs.38.74 lacs)

The V-4 road in Sector 21 has been inspected by the Executive Engineer, Roads Division No. 1, M.C. along with the Sub Divisional Engineer, Roads Sub Division No. 1, M.C. and it is observed that lot of cracks and pot holes have developed on the road surface, causing inconvenience to the public. This road was last carpeted in the year October/2006 and is due for recarpetting.

Accordingly, this revised rough cost estimate amounting to Rs.38.74 lacs has been prepared. The scope of work taken in this estimate is as under:-

1. Dismantling of PCC kerbs & channels.
2. Fixing of new / old PCC kerbs & channels.
3. P/L tack coat @ 3kg/10sqm
4. P/L 40mm thick Bituminous Concrete.
