MINUTES

Commissioner, Municipal Corporation, Chandigarh welcomed the Chairperson and other members present.

In the meeting, Commissioner, Municipal Corporation, Chandigarh briefed about the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014.



The Consulting agency shared the following key points through a PowerPoint presentation in detail about the pilot plan of Ward No. 17, Chandigarh:-

- About the notification on rules, schemes, constitution of Town Vending Committee (TVC), role of TVC and other important events held while preparing for Chandigarh Street Vending Plan;
- About methodology adopted for consulting G.I.S. survey, mapping, preparation of vending/non vending zones;
- Process adopted before survey i.e. I.E.C. development, orientation programme of stake holders, public notices and circulars, advertisement for the survey work plan for public conveniences, etc.
- MIS portal for online data entry and public display of salient features of scheme and act.
- About social economic profile of surveyed street vendors of Chandigarh such as typology, gender distribution, age, literacy, income etc.
- Detailed pilot plan prepared in accordance to Provisions of the Street
 Vending Act in which minimum displacement, use of existing
 resources for space allotment, due care of traffic mobility while
 earmarking vending spaces, the vending zones are identified
 considering community needs.

The draft vending plan for Ward No. 17 was discussed in detail and following decisions were taken:-

- 1. Area adjoining the Educational institutions should be made No Vending Zone.
- 2. The draft plan already sent to the Senior Town Planner (STP) shall be checked by the STP and Chandigarh Traffic Police and will be sent back to the Town Vending Committee (TVC) with observations. In addition, the STP



will identify areas to be designated as Street Vending Zones in Ward No. 17 and inform the TVC.

- Chandigarh Housing Board (CHB) may identify vacant spaces to be marked as Street Vending Zones, if available in CHB Colonies.
- Accessibility norms should be observed keeping in view the physically challenged, blind and other disability (the divyang).
- 5. Sensitivities of all groups including Street Vendors should be considered while making Street Vending Zones to ensure maximizing welfare and minimizing conflicts.
- 6. The revised draft plan prepared by the TVC may be sent to the STP and Chandigarh Traffic Police for comments.

There being no any other agenda, the meeting ended with vote of thanks to the Chairperson.
