**INSTRUCTIONS:-**

1. The street vendors who were not surveyed during the above period will not be entertained.
2. The vending fee along with fee for certificate of vending (License) and ID Card will be deposited at the counter set up through cash/card/POS as per above schedule.
3. The draw of lots for certificate of Vending (Vending License) to Non-Essential Service Providers (N-ESPs) of all wards will be carried on a date to be notified later through public notice.
4. Those street vendors who will not come and deposit fee along with documents will not be considered.
5. The street vendor does not possessing Chandigarh based Aadhar Card will be considered subject to availability of vending sites.
6. The surveyed street vendors who were left in the previous verification and registration camps are also welcome to register in Essential Service Providers (ESPs), Mobile Vendors (MV) and Non-Essential Service Providers (N-ESPs).
