Terms and Conditions:-

1. In case the more than one application received against a site, the allotment will be made by way of draw of lots.
2. The applicant shall have to deposit Rs. 5000/- as a security with this office alongwith ground rent.
3. Preference will be given to local and old venders.
4. The ground rent for the sites located at V-4 road will be Rs. 150/- per day and for the site located at V-5 roads will be Rs. 100/- per day.
5. The area of Coconut water sites should be restricted to 30 ft. x 30ft. and all sites located on V-4 roads should be at least 50 ft. away from the road reservation area.
6. The permission shall be granted for the sale of Coconut waters only and no sale of other fruit, vegetables etc. shall be permitted at these sites.
7. The area around the tent will be kept in a neat and clean condition and no extra tentage, trolleys, bed and baggage etc. shall be allowed.
8. The security amount shall be refunded after the vacation of site and clearance report is received from the enforcement wing.
9. In case the applicant wants to change the location, the security and the ground rent shall be deposited afresh for the new location subject to the availability of the site.
10. The permission is granted only temporarily and the Municipal Corporation reserves the right to withdraw permission any time without assigning any reason.
11. In case the allottee fails to deposit the ground rent for the complete period, the amount of ground rent will be adjusted from the security deposit.
12. The site will be allotted to the applicant from 1st July to 30th Nov.
13. One application will be entertained from one person for each site and separate application shall be required if a person wants to apply for more than one site.
