At the outset, the Secretary welcomed the Mayor, members and officers present in the Committee.

The Commissioner also welcomed the members of the Committee in their first meeting.

AGENDA ITEM NO. 1

Confirmation of minutes of 203rd meeting of the Finance and Contract Committee held on 24.12.2010 at 11.00 a.m. in the Committee Room of MC, Chandigarh.

The Secretary put up agenda item No.1 before the Committee for confirmation.

“The Committee confirmed the minutes of 203rd meeting of the Finance and Contract Committee held on 24.12.2010 at 11.00 a.m.”

AGENDA ITEM NO. 2

Approval of revised estimates for the financial year 2010-11 and budget estimates for 2011-12 of the Municipal Corporation, Chandigarh.

The Secretary put up agenda item No.2 before the Committee for consideration.

The Commissioner explained the budget in detail and said that the opening balance is Rs. 573.00 crore and budget estimate for Plan head has been increased from Rs. 391.80 crore to Rs. 499.98 crore as lot of projects have been approved. Similarly, the budget estimate under Non-Plan head has been increased from Rs. 182.23 crore to Rs. 233.40 crore. The Corporation will taken up projects of upgradation of water supply with Phase- VI & VII, storm water drainage system, S.T.P. and two projects under JNNURM.

Dr. A.P.Sanwaria pointed out that the income from estate has been reduced from Rs. 32.69 crore to Rs. 29.00 crore.

The Commissioner clarified that the price of land is increasing day by day and the office want to hold the auction of property to get the maximum price at later stage.

Dr. A.P. Sanwaria further pointed out that the revenue from parking has also been at lower side. He further pointed out that the allocation of water charges & sewerage cess are at lower side and desired that it should be increased.

The members were of the view that water charges and sewerage cess, as mentioned at page No.9 should be increased from Rs. 5200 lac to Rs. 5500 lac and Rs. 250 lac to Rs. 400 lac respectively.

Dr. A.P.Sanwaria said that under the heading "receipt from Cable Operators" at Page No.5, an amount of Rs. 8.21 lac has been shown as actual receipt against estimate of Rs. 16.00 lac. He said that the cable operators should also deposit the rent in time.

The Commissioner directed the Addl.CMC-I to issue notice to the defaulters to deposit the rent within one month and after that deploy the enforcement staff to remove their cables if they failed to deposit.

The Committee resolved that the cables/poles of cable operators, who have not paid rent, should be dismantled.

The Commissioner said that the enforcement wing will be assigned the duty to remove the cables.

The Mayor said that the rent of the scooter & car bazaar be increased.

The Commissioner asked the Addl.CMC-I to bring an agenda in this regard in the next meeting.

The Mayor further pointed out that the office is allowing hoarding and display boards at various points in the city. However, good revenue can be earned if Advertisement Act

is implemented strictly. He further said that conversion of property should be allowed in Manimajra also as applicable in Chandigarh.

The Joint Commissioner said that the notification of Chandigarh Administration in this regard is applicable to all properties in Chandigarh. However, it will be checked out whether Corporation is implementing it or not.

The Mayor further said that there are number of business hubs in villages like Badheri , Kajheri, Burail & Attawa, from whom conversion charges can be claimed.

The Additional Commissioner clarified that conversion charges can not be charged forcibly. The owner of the property has to apply for conversion of residential property into commercial property.

The Commissioner said that a policy decision has to be taken regarding conversion charges from the shops in villages .

Dr. A.P.Sanwaria further pointed that the estimated revenue receipts under the head "Apni Mandi" for the year 2011-12 have been mentioned as Rs. 30.00 lac whereas it was Rs. 75.00 lac for the year 2010-11 (Page No.10).

The members desired that the estimated receipt should be increased from Rs. 30.00 lac to Rs. 75.00 lac.

Dr. A.P.Sanwaria further pointed out that the revised estimate under the head "Lease money of tele tower" at page 10 has been reduced from Rs. 15.00 lac to Rs. 10.00 lac and asked the reason behind it.

The Commissioner apprised that the F&CC had decided to remove the tele towers but they approached the court and the court has ordered to maintain status quo and therefore, the matter is sub-judice.

Dr. A.P.Sanwaria said that there are number of Verka booths which are not depositing any rent to the Corporation. Action should be taken against them to recover the rent or they should be evicted.

“The Committee decided that the action be initiated under P.P.Act for eviction in case they do not deposit the rent.”

The Revised Estimates for the financial year 2010-11 and Budget Estimates for 2011-12 have been discussed in the 204th meeting of the Finance & Contract Committee held on 24.2.2011 at 3.00 p.m. and the same have been recommended for approval to the General House of the Corporation with certain modifications, which have been incorporated in the Budget Document, as per details given below:

AGENDA ITEM NO. 3

Agenda for the deposit the lease money installment of the Mango Garden, Sector 29, Chandigarh.

The Secretary put up agenda item No.3 before the Committee for consideration.

Dr. A.P. Sanwaria was of the view that such relaxation should be given only in exceptional cases, however it should not be taken as precedent.

The Chief Engineer explained that it is only extension of payment schedule from January to April every year for remaining four years of the agreement.

However, this decision should not be taken as precedent for other cases.”

Dr. A.P. Sanwaria was of the view that open food sellers should not be encouraged as they can cause Jaundice and other diseases and therefore, there should be check on such rehries.

The Mayor said that there are about 150 persons who have been issued licences by the Estate Office to sell Chole Bhaturey etc. between 12.00 noon to 3.00 p.m. They have requested to extend the time from 8.00 a.m. to 5.00 p.m.

Moreover some illegal taxi stands are running in the city, who are not paying anything to the Corporation, which should be identified and removed.

Additional Commissioner-I said that the officials of State Transport Authority should challan such illegal taxies as the Corporation have no power to challan them. Even the Taxi Operators have also parked their taxies in excess of the number for which taxi stands have been allotted.

The Commissioner said that a policy decision has to be taken in this regard. He directed the Additional Commissioner-I to prepare an agenda in this matter.

“The Committee considered & decided that a policy decision should be taken in this regard for which detailed agenda be prepared and placed before the committee for consideration.”

The Commissioner suggested that twenty Tractor Trolleys be approved by the committee, which can be utilized in case their services are required.

The Mayor was of the view that 26 Tractor Trolleys, one for each ward be hired and they can be used for lifting horticulture waste also.

“The Committee considered & resolved that 20 Tractor Trolleys be hired from M/s U.K. Bishwas (Govt. Contractor & General Order supplier) # 2832, Sector 22-C, Chandigarh @ Rs.2150/- per day per Tractor Trolley along with driver, five number of manpower, POL and repair and also approve to keep earnest

money as security by giving relaxation of condition No.16 & 17 of the tender document as requested by the said firm in the public interest. However, MOH will place the order as per the requirement. Tractor Trolleys will lift horticulture waste along with the seasonal waste, dry leaves and garbage at open points for a period of one year.

It was further resolved that if the firm is not in position to supply extra number of Tractor Trolleys, the same rate will be applicable for the other firm after negotiation keeping in view the exigency.”
