

TERMS & CONDITIONS FOR THE BOOKING OF FOOD COURT CONSISTING OF 30 NOS. OF STALLS NEAR VERKA BOOTH INSIDE ROSE GARDEN SECTOR-16, CHANDIGARH

It is informed to the general public that the open auction is being held for the booking of 30 nos. of food stalls/courts (size 10' x 10') for 03 days from 17.02.2023 to 19.02.2023 for selling and serving various food items in the designated theme base food court between 10.00 A.M. to 09.00 P.M. during Rose Festival on the following terms and conditions:-

1. The reserve price for booking of food court is Rs. 5.00 lacs plus 18% GST.
2. The successful bidder/allottee shall have to deposit 25% of the bid amount at the fall of hammer and balance 75% shall be deposited within next two days from the date of auction, failing which money deposited with the MCC shall be forfeited and allotment shall be offered to second highest bidder.
3. The payment shall be made through DD in favour of Commissioner, MC, Chandigarh or through NEFT/RTGS in the account mentioned as below:-

4. The allottee is bound to create different theme based foods corners like Punjabi Dhaba, Delhi Chart, Maharashtra Food, Rajasthan Food, Gujrati Food, Haryanvi Jalebi, South Indian Food, Bihari Food, Kashmiri Food, Ice Cream Parlours, Pop Corn/Sweet Corn Corners with Tea, Coffee, Cold Drink and Water alongwith Pizza, Burger, Sandwich Corners etc. No meat item will be served. Allottee shall have to ensure the suitable dress code for different themes for preparation and serving the food.
5. The allottee must have registered GST number, valid food license and relevant experience in the field to hold various food courts.

6. Quality of food can be checked at any time by respective Govt. agency/official to ensure the quality of food.
7. No advertisement shall be displayed in the food court.
8. The allottee shall have to display the rate list to sell the food items and shall bound to keep the allotted food court and its surrounding area clean and hygienic. In case of insanitation or any encroachment by the allottee beyond the permissible area, the appropriate action/penalty shall be taken or levied as per the rules/regulation/bye-laws of the Corporation.
9. No plastic shall be used for serving the food items.
10. Tentage and adequate furniture shall be provided by MC, Chandigarh.
11. Electrical connection with one 5/15 amp. Socket shall be provided by the Municipal Corporation, Chandigarh alongwith water supply for cooking.
12. The Watch & Ward and Security of eatery items & displayed products shall be the exclusive responsibility of the allottee.
13. The properties of Municipal Corporation shall not be damaged and site shall be got cleaned by the allottee after using the space as zero waste food court is to be maintained by using combustible serving material.
14. The allottee shall obtain a No Objection Certificate from the concerned Health Supervisor of MOH. Further, allottee shall clean all the utensils in the designated space of washing area.
15. The Commissioner, Municipal Corporation, Chandigarh reserves the right to reject the bid without assigning any reason.
16. The Commissioner, Municipal Corporation, Chandigarh shall be the final authority in case of any disputes arises at any stage.
17. The Commissioner, Municipal Corporation, Chandigarh reserves the right to change any of the terms and conditions including addition of any other condition at any time.
