As per record, no written test was conducted for recruitment of Clerks before 2010 and no marks were given for type test/interview. The seniority list circulated on 26.04.2008 and 24.08.2017 was not prepared on the basis of marks. Hence, the objection filed and further promotions have also been made based on the said seniority list. Moreover, Sh. Chandan Kumar was promoted as Sr. Assistant in the year 2010 against the reserved point of physically handicapped. His seniority for the year 2005 cannot be changed and will remain same.	6	5

Admn. vide letter dated 11.12.2014, the age of superannuation in respect of all physically handicapped employees has been increased from 58 years to 60 years. The date of retirement of Sh.
